

## **DEMOLITION PERMITS:**

If the City Fire Department is burning the structure, the following is required:

1. Proof there is no insurance on the structure.
2. Proof the current taxes have been paid on the structure.
3. Complete and pay \$35.00 fee for the attached permit.
4. Request they hire someone to cap the water and sewer lines. They are required to have Dale inspect this capping to insure it is done properly to city code.
5. Ask about the water meter removal and inform them the meter must be turned back into City Hall. They should contact OPPD and Aquila for removal of those meters. However, it is good to remind them about this.
6. Once all of this is complete, we will then contact the Fire Chief to have him schedule a date to burn the structure.

If they are hiring someone to tear down and remove a structure the following is required:

1. Proof there is no insurance on the structure.
2. Proof the current taxes have been paid on the structure.
3. Complete and pay \$35.00 fee for the attached permit.
4. Request they hire someone to cap the water and sewer lines. They are required to have Dale inspect this capping to insure it is done properly to city code.
5. Proof of insurance on behalf of a contractor such as a Certificate of Insurance. (If the structure being demolished is on a large scale and can affect surrounding property owners, it will need to be discussed with City Administrator as a surety bond could be required.)
6. Ask about the water meter removal and inform them the meter must be turned back into City Hall. They should contact OPPD and Aquila for removal of those meters. However, it is good to remind that about this.
